WHAT WE CAN DO FOR YOU

We can support your access to government investment capital at the national and local levels. Make contact with the people who make the decisions.

The Registry is suitable for fund managers raising investment capital, and for medium to large corporates raising equity capital or bonds.

Typical fund raises are from £5 million upwards.

We have direct access to all 86 local government pension funds and the 8 pooled funds along with most public pension funds, their treasurers and chairs, along with 482 investment officers and trustees.

LOCAL GOVERNMENT PENSION FUNDS

Local government pension funds hold over **£350 billion** of assets on behalf of 6.4 million people. ⁽¹⁾

Our research reveals that due to government pressure to boost returns for pensioners by investing in the UK, investment officers are making allocations into alternative fund managers, and directly into companies, as they look for capital growth and income in support of their ageing membership.

The UK has the greatest potential to invest in businesses having only 8% currently in the alternative sector, compared to an average of 26% across the seven largest pension markets. ⁽²⁾ ⁽³⁾

HOW IT WORKS

We build each of our clients a unique pitch page on The Registry which contains information about you and your investment proposition. We can include your pitch video and graphical content.

There are buttons to download your pitch deck and supporting documents. Finally, there is a call-to-action system through which investment officers and government officials who are interested in your proposals, can be placed in direct contact with you.

HOW WE PROMOTE YOUR FUND RAISE

All our clients are promoted through newsletters, individual targeted email campaigns, events and meetings. The contacts we approach are bespoke to each client, addressing your unique fund-raising needs.

We work with you to amend and adapt your pitch based on feed-back and to capitalise on emerging opportunities.

Whenever possible we will arrange for you to meet with politicians, high ranking civil servants and investment decision makers.





SUBSCRIPTION

We charge a monthly subscription fee of £380 plus VAT for promoting your fund raise on The Registry. There is no long-term contract, you can cancel with 30 days' notice. **The first 30 days is free of charge, and you can cancel within that same 30 days at anytime without notice.**

PLACEMENT AGENT

We can act for you as an exclusive full-service placement agent. We contact investment officers and senior management promoting just your fund raise, arrange and attend and meetings with you etc. The cost for this level of service is £5,000 plus VAT per month. NOTE: We do not charge placement agent clients for political lobbying services if required for fund raising purposes.

THE SUCCESS FEE

If we successfully support a fund raise on your behalf, we charge a success fee based on the capital raised*. This fee is payable within three months of the capital being received by you.

* The success fee is 0.5% for fund managers and 3% for direct investment
